Cargo and UK Goods in Transit

#### **Target market**

UK domiciled importers, exporters, manufacturers, wholesalers and distributors. Goods owners who require import, export, UK distribution and storage cover.

Annual Cargo and Stock Throughput cover for physical loss or damage to goods whilst in the course of transit by sea, air or land, or whilst in storage by an insured event or peril subject to policy clauses, conditions and exclusions.

Non-commercial customers

Any business domiciled in any other territory other than those territories detailed in who the product is designed for.

Policies can exclude the following (not limited to & dependant on individual policies & terms):

Buildings, fixtures, fittings and machinery. However this shall not apply whilst such property is insured in the ordinary course of transit as defined within the Institute Cargo Clause

- Business interruption and other contingent risks
- Compound risks or vehicle storage not in the ordinary course of transit as defined within the Institute Cargo Clauses
- Consequential loss unless resulting from a Marine insured risk
- Computer software and hardware other than prior to installation
- Storage within any basement
- Storage without any transit cover
- Storage within chemical plants or tank Farms
- Storage within manufacturing or industrial plants
- · Manufacturing and/or processing risks
- Storage within mill buildings
- Storage outside or within temporary structures
- Storage at retail premises

In addition to this General exclusions can include 1) War etc 2) Institute Radioactive Contamination, Chemical, Biological, Bio-Chemical and Electromagnetic Weapons Exclusion Clause, 3) Marine Cyber 4) Sonic Bangs 5) Contracts (Rights of Third Parties) Act 1999 Exclusion Clause (Cargo), 6) Termination of Transit Clause (Terrorism), 7) FCA Regulations 8) Communicable Disease Exclusion.

Please note that this list is exhaustive & dependant on each individual policy.
